# Mental Health Awareness Month Virtual Background

Mental Health Awareness Month is recognized each May o raise awareness and reduce stigma surrounding mental conditions.





Mental Health Awareness month was first celebrated in 1949 and was founded by the organization now known as Mental Health America (MHA). MHA has designated this year's theme to be "Look Around, and Look Within," encouraging everyone to consider how the world around them effects their mental health. This year's theme considers nonmedical factors (Social Determinant of Health, neighborhood, environment, education etc.) that contribute to our mental health and well-being.

California also has a statewide theme, #Share4MH to promote engagement in reducing stigma surrounding mental conditions:

- · Share how you get support for your mental health.

### San Mateo County Supports Food Security in Our Communities

California Senate Bills (SB) 600 and 348 support the wellbeing of CalFresh recipients and students. SB 600 would raise the minimum monthly nutrition benefit for all CalFresh recipients. SB 348 would ensure all California students receive two nutritious meals and sufficient time to eat each school day. ### Redwood City Together (RWCT) hosts Community Impact Celebration

RWCT works to advance the success of youth and families in Redwood City and North Fair Oaks through community collaboration. On April 6, the organization hosted an event to celebrate the launch of its multi-year grant from Silicon Valley's Social Venture Fund. The goals of the collective impact collaborative are to:

- Ensure all children, youth, and families live in safe, healthy, and supportive environments
- Build resilient children and youth by expanding developmental assets
- Provide targeted support to address unmet needs at key ages



# BOARDS AND COMMISSIONS VACANCIES

Boards and Commissions Vacancies There are multiple boards and commissions vacancies for the City of San Bruno, City of Redwood City, and County of San Mateo.

City of Redwood City: The City of Redwood City has vacancies on their Police Advisory Committee and Transportation Advisory Committees. The Police Advisory supports partnership and transparency between the community and the Police Department. The Transportation Advisory's mission is to Increase safe, attractive, sustainable, and comfortable access and independent travel options for the Redwood City community, present and future, by promoting and utilizing Complete Streets principles and practices.

Deadline to apply is April 30.

City of San Bruno: The City of San Bruno has one partial term expiring on 10/31/24 on their Parks and Recreation Commission. The Parks and Recreation Commission makes recommendations to the City Council regarding community recreation need. Deadline to apply is at 5 p.m. on May 5.

County of San Mateo: There is currently one vacancy on the Parks and Recreation Commission and three vacancies on the North Fair Oaks Community Council. The Parks and Recreation Commission is an advisory body that makes recommendations to the Board of Supervisors regarding efforts to enhance parks, recreational and educational opportunities. Deadline to apply is at 5 p.m. on May 19. The North Fair Oaks Community Council addresses the needs of the community and serves as an advisory council to the Board of Supervisors on those matters which relate to the North Fair Oaks community, including, but not limited to, advice on matters of public health, safety, welfare, public works, policy, planning, community development, program development, and services pertaining to North Fair Oaks. Deadline to apply is at 5 p.m. on June 2.










## **COMMUNITY COLLABORATION HIGHLIGHTS**

### **Leadership Collaborative**

The Leadership Council San Mateo County believes communities are stronger when a diversity of leaders are connected, knowledgeable, and targeted in their efforts to create positive change. This year, Health Policy and Planning (HPP) staff participated in the Building Healthy Communities Day with the Leadership CORPS (senior leaders) and the Emerging Leaders cohorts. HPP's presentation focused on upstream prevention and engaging in a dialog to identify strategies for addressing social determinants of health. Survey comments from participants included:

### **Creating Safer Streets**

In April, the San Mateo County Office of Education hosted four walk audits at schools in Daly City, Pacifica, and Half Moon Bay. These walk audits were facilitated by national transportation and public health consultant, Mark Fenton. The walk audits brought together a diverse group of stakeholders to assess walkability, pedestrian access, and bikeability near the schools. The next step will be to elevate these issues with each city and to consider implementing road safety measures for pedestrians and bicyclists.

#### Farmworker Health in California Study

On April 17, Attorney General Rob Bonta held a virtual dialogue on actions taken by leaders in California to protect the health and rights of farmworkers. The forum highlighted findings from a recent study by UC Merced's Farmworker Health in CA Study. The study found that more than a third of all CA farmworkers are living with chronic diseases such as diabetes, hypertension, and anxiety. Additionally, about half have no health insurance. Results from the study's findings aim to improve work environments in agriculture. Key actions include expanding access to health care, strengthening economic and safety net services, and protecting worker rights. For more study highlights go to
